**Sodus Township Library Millage Renewal Proposal**

**WHEREAS,** The Sodus Township Board wishes to continue to provide for library support, maintenance, operation, and improvements: and

**WHEREAS,** the Sodus Township Library Millage Renewal was previously-voted in the tax limitation imposed under Article IX, Sec. 6 of the Michigan Constitution in Sodus Township of 0.4 of one mill (\$0.40 per \$1,000 of taxable value), be renewed at that same amount and levied for four (4) years, 2024 through 2027 inclusive, for the purpose of providing operating funds for library support, maintenance, operation and continued improvements of the Sodus Township Library, raising an estimated \$33,353.00 in the first year the millage was levied.

**WHEREAS,** The Sodus Township Board gives the Sodus Township Library Board the authority to use the library millage for the purpose of supporting library operations, maintenance of the building and property, and other operational support of the Sodus Township Library.

**NOW, THEREFORE, BE IT RESOLVED,** The Sodus Township Board approves the following Library Millage Renewal Proposal ballot language and directs the Sodus Township Clerk to submit it for placement on the August 6, 2024 election ballot.

Library Millage Renewal Proposal

Shall the expired previously voted increase in the tax limitation imposed under Article IX, Section 6 of the Michigan Constitution in Sodus Township, of 0.4 of one mill (\$0.40 per \$1,000 of taxable value), be renewed at 0.4 of one mill (\$0.40 per \$1,000 of taxable value) and levied for four years, 2024 through 2027 inclusive, for the operation and for all other library purposes authorized by law, for the Sodus Township Library, thereby raising an estimated \$33,353.00 in the first year the millage is levied?
